Short description:

Through the subproject “efficient energy planning” a half-day workshop was arranged in Åmål, Västra Götaland with the subject of initiation, objectives, implementation and follow-up of local energy plans.

Municipal officers from 13 municipalities in the Västra Götaland region participated together with personal from the regional energy agency and other energy experts.

Background:

Municipal energy planning is an important action to create the necessary means for a successful integration and development of RES-e production plants on local level. A group of 19 municipalities has, together with the regional energy agency and the regional administration, formed a coordination and cooperation project called “Sustainable development West”. One of the actions within this network is to operate a subproject called “efficient energy planning” with the aim of supporting the municipal officers in the work with energy planning and to promote and enhance the development of a sustainable energy system.

Aim:

The aim of the workshop was to discuss and share knowledge and experiences between the municipalities and to highlight the specific barriers in planning for RES-e at local level.

The workshop started at 10.00 and ended 15.00.
